


### **EDUCATION**

Teaching and research are the major employment opportunities; however financial accounting, budget and financial analysts positions are available.

### **GOVERNMENT**

Government accountants may work within all three levels of government (local/state/ federal) and administer and formulate budgets, track costs and analyze programs. Government accounting offers diverse employment opportunities. At the federal level, employment is available with the Department of Defense, Homeland Security, FBI, Secret Service, General Accounting Office, IRS and many other federal agencies.

### PRIVATE INDUSTRY

Most businesses have an accounting function which prepares financial statements, tracks costs and handles tax issues. The private sector offers exciting advancement opportunities in positions as internal auditors, budget and financial analysts, financial and management accountants, cost or tax managers, and forensics.
