- The college recommends the use of WES (World Education Services) for the evaluation of your high school education completion.
 - For WES, your evaluation can be requested at <u>www.wes.org</u>. At a minimum, you must request the DOCUMENT-BY-DOCUMENT REPORT. However, if you have college credits, you may wish to request the course-by-course report.
- We will also accept evaluations from other credentialing services provided that the credentialing service is a member of the National Association of Credentialing Evaluation Services.
